## What is the quick turnaroud service about?

- Evaluation service only (PTA and approx. REL only)
  - No haplotypes/BBR/PV/some traits (health/RFI/etc).
- Limited number of traits (max. 15; see policy for full list).
- Females only
- Snapshot evaluation
- Ultra-fast (< 5 mins from posting of genotypes)</li>
- No ID required, no pedigree, very limited QC



### Main target

- Commercial herds with limited information on pedigrees
- Selection and culling tool for young female calves
- Mostly international markets



#### How to access this service?

- Request to access (\$1000 setup cost)
  - Chip to be used (+30k for good results)
  - Traits to receive evaluations for
  - Preference in terms of input/output (typically, the same as in "full service")
  - End User Agreement signature
- CDCB sets up the system for all breeds (+ documentation for the user)
  - Solutions updated each triannual run
- Testing phase (no charge)
- Production phase



#### Some important differences with "Full service"

- Other than the ones already mentioned:
  - Genotypes not stored in CDCB database (no queries)
  - Limited genotype file storage
  - Separate folder (to avoid confusion)
  - Completely automated system (*independent from* "freezes" or routine maintenance to the database)

#### Documentation and costs

- Cost of evaluations: \$1 per animal
  - If valid ID17 provided, animals can obtain discount when requesting "full service"
